The Child and Adolescent Psychiatry Program, Department of Psychiatry accepts applications of Graduates from:

LCME ACCREDITED SCHOOLS OF MEDICINE

- 1. Personal Statement in Spanish (in addition to English version). Please, send the Personal Statement in Spanish topsychiatrycoordinator.rcm@upr.edu
- 2. Two <u>official</u> Transcripts (with your cumulative average grade point-GPA) from Undergraduate and Medical School.
- 3. Official copy of your Diploma of Medical School. **
- 4. It is highly recommended that among the three letters of recommendation, at least one should be from the Program Training Director. (a) Candidates, who graduated more than one year prior to the application, must submit a letter of recommendation from most recent employment/clinical work experience supervisor(s).
- 5. Compliance with the UPR-School of Medicine Graduate Medical Education Office requirements. **
- 6. <u>Official</u> approval of the USMLE 3 is an Institutional and Program requirement in order to start our Residency Training in Child & Adolescent Psychiatry. It must be approved not later than May 31st of the PGY I level. <u>ALL USMLE PARTS (Step 1, Step 2-CS, Step 2-CK, and Step 3)</u>, can be taken a maximum of three (3) times, including all attempts before the start of the Residency Program.
- 7. Provisional or permanent License to practice Medicine in Puerto Rico. **
- 8. <u>Official</u> Evidence of the Registration for the National Residency Matching Program (NRMP). Please send the evidence to psychiatrycoordinator.rcm@upr.edu.
- 9. Fully bilingual Spanish/English (Fluency in speaking, reading, comprehension and writing in both languages).

Additional Requirements to ERAS Application * Academic Year 2022-2023

The Child and Adolescent Psychiatry Program, Department of Psychiatry accepts applications of Graduates from International Medical Schools (Recognized by the Puerto Rico Board of Medical Examination and as listed by the World Health Organization):

- 1. If Candidate is not a USA Citizen, he/she must have J-1 or H-1B Visa permit.
- 2. Personal Statement in Spanish (in addition to English version). Please, send the Personal Statement in Spanish to psychiatrycoordinator.rcm@upr.edu
- 3. Two <u>official</u> Transcripts with your cumulative average grade point-GPA) from Undergraduate and Medical School.
- 4. <u>Official</u> evidence that your International Medical School is approved and recognized by the "Junta de Licenciamiento y Disciplina Médica de Puerto Rico (JLDMPR)" (Puerto Rico Board of Medical Examiners). http://www.salud.gov.pr/Programas/ORCPS/JLDMPR(787)999-8989 and the WHO.
- 5. Official copy of your Diploma of Medical School.**
- 6. It is highly recommended that among the three letters of recommendation, at least one should be from Program Training Director. (a) Candidates, who graduate more than one year prior to the application, must submit a letter of recommendation from most recent employment/clinical work experience.
- 7. Compliance with the UPR-School of Medicine Graduate Medical Education Office requirements.**
- 8. Official documentation of provisional or permanent License to practice Medicine in Puerto Rico.**
- 9. <u>Compliance with ECFMG</u> currently valid certificate and completion of all parts of the USMLE no later than October 30, 2018. <u>Official</u> approval of the USMLE 3 is an Institutional and Program requirement inorder to start our Residency Training in Child & Adolescent Psychiatry. <u>ALL USMLE PARTS (Step 1, Step 2-CS, Step 2-CK, and Step 3)</u>, can be taken a maximum of three (3) times, <u>including all attempts</u> before the start of the Residency Program.
- 10. Fully bilingual Spanish/English (Fluency in speaking, reading, comprehension, and writing in both languages).
- 11. <u>Official</u> Evidence of the Registration for the National Residency Matching Program. Please, send the evidence to psychiatrycoordinator.rcm@upr.edu
